**TENDER CALL NOTICE**



- The successful tenderers should deposit 10% of the total cost of the materials towards security & execute an agreement in non judicial stamp paper within three days from the date of receipt of the advice from the Principal, E.M.R.S, Ranki, Keonjhar.
- The sealed tender should be accompanied with the following documents.
  - Up-to-date VAT clearance certificate, Income tax certificate & Orissa State Tax.
  - Document in support of the manufacture, authorized dealers etc.
  - EMD in shape of Bank/FDR placed in favour of Principal, E.M.R.S, Ranki, Keonjhar.
- Tender received beyond the stipulated date and time shall be liable for rejection.
- The tenderer has to bear the responsibility for proper delivery of goods at EMRS, Ranki, School site and should bear the loss/damage during course of transit.
